The Federal Democratic Republic of Ethiopia (FDRE) has received financing from the African Development Bank toward the cost of the **Eastern Ethiopia Electricity Grid Reinforcement Project**, and intends to apply part of the agreed amount for this grant to the payments under the contract for **Consultancy Services for Wind Measurement and Feasibility Studies**.

The services included under this project are:

- Relocation of eight (8) existing masts and one (1) LiDAR to new locations to new potential sites (Ziway, Seladingay, Adama- Minjar area, Mega, Asela, Kebribeyah and Afar Zone 1),
- Database (data collection scheme) and associated machines set up for to operate relevant Applications and data.
- Conduct respective measuring campaign for one year with its relevant report.
- Produce bankable energy resource assessment reports for each site with its relevant capacity building arrangement.
- Prepare two Feasibility Studies (one for each site)
- Prepare two ESIA studies (one for each site).
- Provide technical assistance and capacity building for the Ethiopian Electric Power (Client) staffs to allow the Client to relocate other masts from different sites, continue more sites data collection and conduct feasibility studies using its in-house capacity built through this consultancy service assignment.

It is expected that the consultancy service assignment will take **18 months**.
